

## Terms of Use

The service provided by Yamaten, Inc (hereinafter referred to as “our company”) “mountain weather forecast” (hereinafter referred to as “our service”) can be used after you apply for paid service and accept the Terms of Use.

### Article 1 (Use of this service)

1. Contract conclusion and cancellation can be performed only from the PC, smartphone, or mobile phone terminal used by you in accordance with the method defined by our company.

2. You may not transfer, assign, secure, or otherwise dispose of the rights and obligations related to the Terms of Use to a third party.

3. We regard contract conclusion and cancellation procedures as offers from customers themselves.

4. You shall not act in a manner that threatens, restricts, interferes with, or imperils the rights of our company or any third party.

5. If you violate the Terms of Use (including not paying information fees), we may suspend or cancel service without notice.

6. After cancellation, you will immediately be unable to use the service, even in the middle of the month.

### Article 2 (Method of identifying members and their management and responsibilities)

1. This service identifies a member by the combination of the member's e-mail address and password. Members will be able to use this service by using this combination of e-mail address and password.

2. Members are solely responsible for the management and use of their e-mail address and password. You are solely responsible for all use of our services using your e-mail addresses and passwords, whether by yourself or a third party.

3. Even if the member suffers damage as a result of the member's e-mail address and password being abused by a third party, our company shall not be liable for any damages whatsoever.

#### Article 3 (Fees)

1. The fee for this information service is 300 yen per month (excluding a consumption tax).

2. The information fee will be charged from the day of the month on which the monthly membership contract is concluded.

3. If you do not cancel the monthly membership contract, it will be renewed automatically the following month.

4. The information fee for the first month is prorated.

5. The information fee for the month after cancellation of the monthly membership contract will be for one month, even in the middle of the month.

6. After the information fee has been paid, you will not be given a refund in any circumstance.

7. In addition to the information fee, a communication fee will be charged.

8. You are obligated to pay regardless of circumstances.

9. Charge disputes will be settled between you and us.

1. If the customer cannot connect to the network or if all or part of the service cannot be used for other reasons, we will not be liable for any reason.
